

**LDExtras Monthly Shopping Spree  
Official Contest Rules**

To enter you must be a registered LDExtras Program member in good standing. You will automatically be entered for a chance to win when you become a LDExtras Program member and then each time you earn a "Visit" under the LDExtras Program. To enter without purchase, LDExtra members can mail in their name, Member Identifier, email address, and a 100 word handwritten letter on what they would purchase if they win the LDExtras shopping spree. Each entry needs to be in a separate envelope and will count as a valid single entry. Each entry needs to be in a separate envelope and will count as a valid single entry. There is a maximum limit of five entries per Member per day from all sources, including entries based on member sign-up, Visits and on a without purchase basis. Any entries received in excess of five in one day will be discarded.

A random draw will be made on a designated day of each month the contest runs, based on all Member entries received throughout the preceding calendar month. Any valid entries that are not received for any reason by the last day of the current calendar month will be included in the following month's contest. All valid entries received during March 2015 will be included as entries for the April 2015 contest.

To win, selected entrants must correctly answer a skill-testing mathematical question and sign the *Declaration* and Release in form required by London Drugs which, among other things: confirms compliance with the contest rules and acceptance of the prize(s) as awarded; releases London Drugs from liability in association with the contest and prize; and consents to the use of their name, photograph, voice and statements for promotional and publicity purposes. A selected entrant that is under the age of majority in the province where they reside will need a parent or legal guardian to sign the Declaration and Release.

There will be 1 (one) prize of a \$2,500 London Drugs Shopping Spree available to be won.
