

**LDExtras Monthly Shopping Spree
Official Contest Terms and Conditions**

1. **Eligibility:** LDExtras Monthly Shopping Spree Contest (the “Contest”) is open only to persons who are at the time of Contest entry: (1) an LDExtras member in good standing; (2) a legal resident of one of the following Canadian provinces: British Columbia, Alberta, Saskatchewan or Manitoba;(3) have attained at least the age of majority in their respective province of residence (nineteen (19) in British Columbia, and eighteen (18) in all other provinces); and (4) are not an employee of, or an immediate family member (e.g. spouse, parents, siblings and children) or household member of any employee of London Drugs, their respective advertising and promotional agencies or the independent judging organization. The Contest is subject to all applicable laws and regulations and is void where prohibited.
